The 100 member Evergreen Chorale presented the following musical performances and activities: 21 fully-staged musical theatre performances (attendance 3009); 2 holiday concerts with Kutandara, a percussion group from Boulder (attendance 645); 2 spring concerts (attendance 256); and collaborations with the Evergreen Chamber Orchestra (attendance 200) and the Jefferson Symphony Orchestra (attendance 950). In addition, we held a two-week summer music camp (enrollment 98) and presented camp showcases which entertained 486 people, and performed at two free events in our community.

The Evergreen Chorale owns Center Stage and the Rotary Gallery in its lobby. This venue is dedicated to serving the performing needs of the mountain community and provides rehearsal and performance space at affordable rates to local groups.
