The 100 member Evergreen Chorale (dba Ovation West Performng Arts) presented the following musical performances and activities which engaged a total of 5970 patrons: 25 fully-staged musical theatre performances (attendance 2805); 4 Evergreen Chorale performances (approximately 90 singers and attedance 827); 3 additionsl concersts at Center Stage (attendance 336); a free community event at Center Stage (attendance 150); a musical theatre workshop for middle school children (attendance 20;)a performance at the Evergreen Music Festival (attendance 1000), 2 performances at an elder-care facility (attendance 100); and summer music camp classes (enrollment 74) and showcases (attendance 420).
